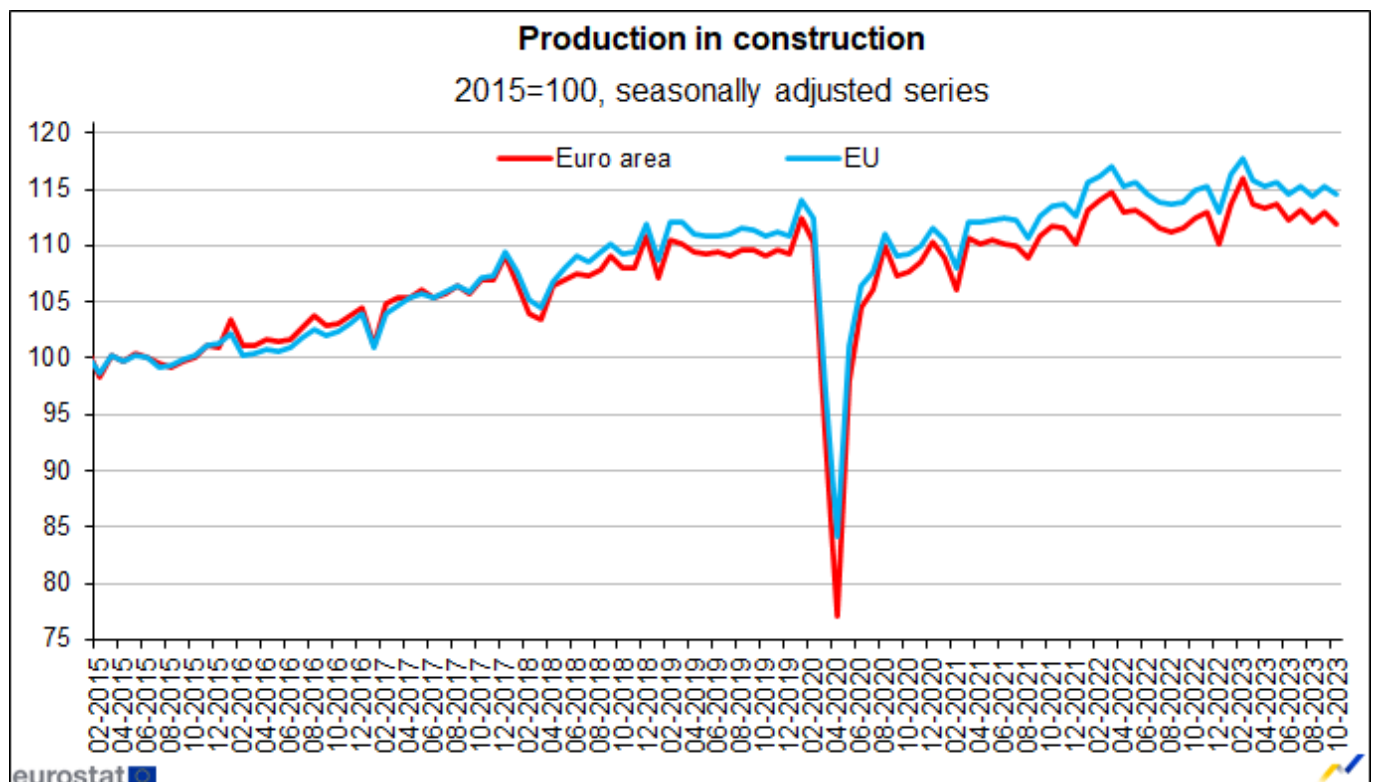
October 2023 compared with September 2023

## Production in construction down by 1.0% in the euro area and by 0.6% in the EU

Down by 0.7% in the euro area and by 0.4% in the EU compared with October 2022

In October 2023 compared with September 2023, seasonally adjusted production in the construction sector decreased by 1.0% in the **euro area** and by 0.6% the **EU**, according to first estimates from **Eurostat, the statistical office of the European Union**. In September 2023, production in construction grew by 0.9% in the **euro area** and by 0.7% in the **EU**.

In October 2023 compared with October 2022, production in construction decreased by 0.7% in the **euro area** and by 0.4% in the **EU**.



## Monthly comparison by construction sector and by Member State

In the **euro area** in October 2023, compared with September 2023, civil engineering decreased by 1.0% and building construction by 0.9%.

In the **EU**, building construction decreased by 0.6% and civil engineering increased by 0.5%.

Among Member States for which data are available, the largest monthly decreases in production in construction were recorded in **Slovenia** (-6.1%), **Germany** and **Slovakia** (both -2.2%) and **France** (-2.0%). The highest increases were observed in **Romania** and **Sweden** (both +3.0%), **Spain** (+1.4%) and **Austria** (+1.3%).

## Annual comparison by construction sector and by Member State

In the **euro area** in October 2023, compared with October 2022, building construction decreased by 0.8% and civil engineering by 0.2%.

In the **EU** building construction decreased by 0.8%, while civil engineering increased by 1.8%.

Among Member States for which data are available, the largest annual decreases were recorded in **Finland** (-7.3%), **Sweden** (-4.6%) and **Belgium** (-3.5%). The highest increases in production in construction were observed in **Romania** (+9.2%), **Spain** (+8.3%) and **Poland** (+7.5%).

## Geographical information

The **euro area** (EA20) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU27) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

Estonia, Greece, Croatia, Cyprus, Latvia, Lithuania, Luxembourg and Malta are not required to supply monthly data within 1 month and 15 days after the end of the reference month under Regulation (EU) 2019/2152. Ireland has a derogation to remain with quarterly frequency and Denmark to have a longer deadline until the end of 2023.

## Methods and definitions

The **index of production in construction** approximates the evolution of the volume of production within the sector, broken down into building construction and civil engineering.

**Seasonally adjusted** euro area and EU series are calculated by aggregating the seasonally adjusted national data. Eurostat carries out the seasonal adjustment of the data for those countries that do not adjust their data for seasonal effects.

The monthly index as presented in this News Release is calculated only on the basis of the data of those countries reporting monthly data. Missing observations from Member States for recent months are estimated for the calculation of the euro area and the EU aggregates.

## Revisions and timetable

Data of previous months have been revised compared with those issued in News Release [131/2023](#) of 20 November 2023. The monthly percentage change for September 2023 was revised from +0.4% to +0.9% in the euro area and from +0.5% to +0.7% in the EU. The annual percentage change has been revised from -0.3% to +0.7% in the euro area and from +0.1% to +0.6% in the EU.
